Photograph shows parade floats travelling on 100 block of 8th Street (Brandon). Horse-drawn floats appear to belong to the Amalgamated Society of Carpenters and Joiners,

Murdock/Murdoch Brothers (furniture dealers), and F.W. Durst (cement contractor).

Businesses visible in the background include the Sylvester Brothers Manufacturing Company and McDiarmid and Clarke lumber and fuel yard. Spectators in the foreground are leaning on a wooden fence likely belonging to the Old City Hall.

Notes: Writing on the front of the photograph matting reads: 315 July 1906. Two


