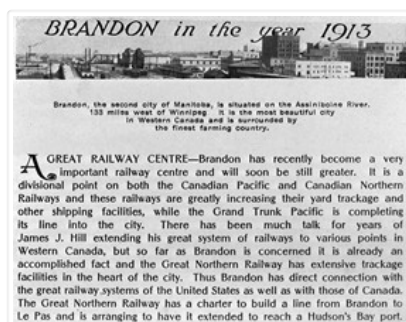

An observation tower and possible gazebo for dignitaries is located inside the track.

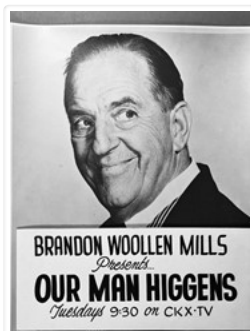

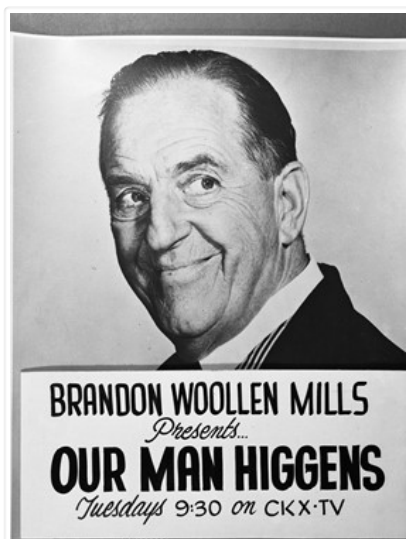
