Biographical:

Thompson's Groceries and Confectionary was established in 1923 by Arthur Thompson (b. 1881 - d. May 14, 1957) at 764 13th Street. From approximately 1925-1927, the store was operated by Alexander Thompson at 762 13th Street. The fate of the store from 1929-1935 is unclear. In 1929, Alexander Thompson was a grocer at 748 7th Street and in 1931 a Mrs. A Thompson was a grocer at 802 14th Street. There were two Thompson grocery and confectionary businesses in Brandon in 1933: Thompson's Confectionary at 745 13th Street and Thompson & Co. at 702 12th Street.
