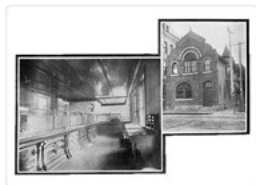

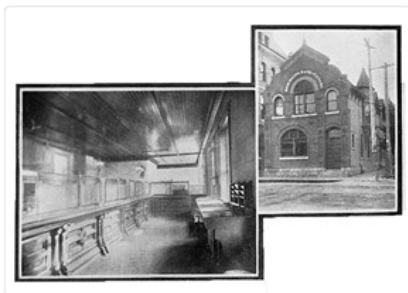

Borbridge Western Ltd. had extensive contracts with Canadian Army Cavalry during WWI.

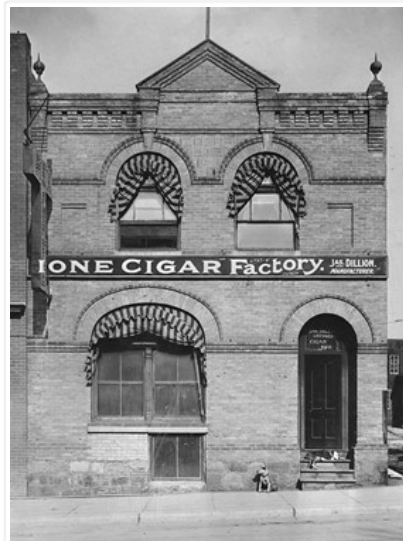

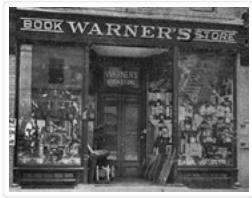

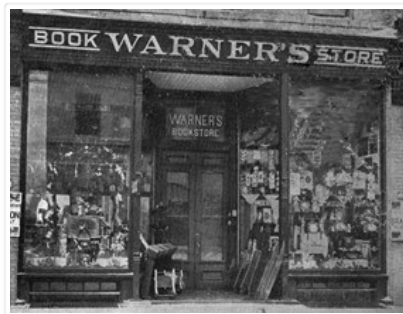
