DR. EVANS . . . A TRIBUTE

On Thursday, July 23, 1959, with the passing of Dr. Evans, Brandon College lost its president; the province—one of its leading educators.

For thirty-one years Dr. Evans guided the welfare and development of Brandon College. Starting as an instructor in 1911 he rose to become principal of the academic department, professor of geology, dean, and finally president of the College in 1928. Throughout these years, in whatever capacity, he worked faithfully and untiringly for the betterment of education in this province, and made, by his efforts, an outstanding contribution to education, not only in Manitoba but in the British Commonwealth.


To many people in this province he was the symbol of higher education. To the many students who passed through Brandon College he was always a friend, and to his fellow teachers he was an inspiration and an example to be followed. By all he was highly respected.

Being a man of vision he had dreams for Brandon College—a dream which at last is to become reality. On the eve of its expansion, Brandon College misses Dr. Evans. Notwithstanding, the new buildings and greater facilities which will be offered to the students of Western Manitoba will remain a reminder of a great public-spirited citizen who devoted his life to the education of our youth.

SIX APPOINTED TO BRANDON COLLEGE POSTS

Six new faculty members have been appointed to Brandon College for the 1959-60 term, thus bringing to thirty-one the number of full or part time instructors on staff. New appointments are:

- Dr. Richard Laskin of New York City, as head of the Sociology department, which for the first time is offering a full course sequence.
- Miss Helen Kerr Wright of Brandon, junior Latin instructor.



- Miss Eileen McFadden of Rivers, as head librarian.
- Mr. William Peters, Winkler, appointed to the Education faculty.
- Miss Louise Chapman, Brandon, teacher of piano and theory in the Music department.
- Lucien Needham, Winnipeg, vocal instructor in the Music department.

J. R. C. EVANS LOAN FUND

SOMETHING NEW

MINISTER BREAKS GROUND

Two hundred supporters of the college braved 45-degree weather on September 9 to attend the official sod turning ceremony marking the start of construction of a new \$915,000 Arts and Library building on the college campus. Hon, Stewart McLean, minister of education, turned the first sod. The minister told those in attendance at the ceremony that the increase in the number of students attending high schools in Manitoba has made provision of facilities for higher learning increasingly important, and that the government is prepared to make Brandon College the second centre of higher learning in the province. W. F. McGregor, chairman of the College Board presided at the ceremonies. Other speakers were: Dr. A. E. McKenzie, honorary chairman of the board; acting mayor William Boreskie of Brandon; president H. H. Saunderson of the University of Manitoba; Dr. H. S. Perdue, Dean of Arts and Science at Brandon College; and R. O. Lissaman, M.L.A.

The new building will be situated west of the present structure which will be demolished in the later stages of the expansion programme. It includes space for a 60,000 volume library, ten arts classrooms, eight staff offices and a lecture theatre seating 250 students. It will be used for the first time at the opening of the 1960 fall term.

MRS. W. L. WRIGHT DIES AT ROBSON

Many friends were saddened by the passing this fall of Annie (Evans) Wright at Robson, British Columbia.

A sister to Dr. J. R. Evans, Mrs. Wright came to Canada from Devonshire in 1888. Her first contact with Brandon College was as an instructor in the Commercial Department. Consequent to this she received the Bachelor of Arts Degree from Brandon College and the Master of Arts from Chicago University.

She returned to Brandon College as professor of English for some years, later to become Dean of Women in Clark Hall.

Mrs. Wright is survived by her husband, Dr. W. L. Wright, Professor Emeritus of Brandon College, Music Department, who resides in Robson.

MORE SERVICES

It is exciting, these days, to be involved in the work of Brandon College at a stage when it is growing in resources, growing in the numbers of its student body and growing, very obviously, in the extent of its importance to the people of Western Manitoba, indeed, even of Canada.

Having a share in Alumni work, one becomes tremendously enthusiastic about the achievements of the Association in developing the present loan scheme, keenly interested in the progress and in the personalities of the individual students who have been helped. It is not easy, however, to convey this interest and excitement to the Alumni, on whose shoulders the continued success of the scheme must rest.

Again, it is difficult to convey to individual Alumni the importance of their support of the Association and of the College, through the Association—both moral support and financial. We have come to this work recently enough to remember that when we received a copy of the Alumni News—with an appeal for dues—we indeed intended to send a cheque. But, frequently, like the majority of Alumni, we let the year slip by without doing so.

The Alumni Association, with the support of Brandon College, plans to increase its services. But, if the support of the College is to be justified—and continued in the future—there must be participation indicating interest by a greater number of Alumni Take the matter of payment of dues-modest enough at two dollars a year Of about 2000 graduates on our mailing list, only fifty are paidup life members and only eighteen have paid dues for the current fiscal year. If the Association is to continue to go ahead (which it must do—or fall back), there must be an increase in material Alumni support.

We believe that the majority of Alumni have every intention of paying dues—and of contributing to the Loan fund. We appeal to you to DO IT NOW! Please don't let it slide.
